The 10th SICET Executive Board Committee Meeting Summary of the 1st Meeting

The Executive Board Committee held its 1st meeting online at 10pm EST on December 22, 2013. The Committee reached consensus on the following topics.

Topic 1: EITT 2013 & SICET/AECT 2013 Conference Report

Chih-Hsiung Tu, Shuyan Wang, and Xibin Han reported on the SICET/AECT 2013 and EITT 2013 conference. Overall, both conferences were successful. EITT 2013 achieved the goals of being a high-level international scholars' forum, good size of attendees and presentations, and a balanced budget. The SICET 10th Anniversary Ceremony was systematically held and developed the solid foundation for the new term of board members.

Topic 2: SICET Organizational Structure Reform

The new board members believe it has not been easy for SICET to develop over the past ten years. There are some achievements; however, a reform is deemed necessary. Drawing on SICET's previous achievements and continuing its mission, the new board proposed a new organizational structure to make SICET become an internationalized, highly professional, specialized, regulated, and sustainable organization. This new structure includes:

- a. Steering Committee
- **b.** Executive Committee
- c. Board of Directors
- **d. Office and Committees** (Office, Development and Management Committee, Academic Committee, District Committee, and Technology Committee).

Board members had thorough discussions on the proposed new structure, and deliberated the obligations and responsibilities, limit of terms, coordination, board member nomination, and by-law revisions. All attendees believe this reform is very important to SICET and will have significant impact on the organization's long-term development. SICET encourages everyone to take an active part in implementing the reform.

Topic 3: SICET Specific Tasks for the next month

The first online board meeting was successful and ended pleasantly in members' agreement on the new organization structure. This meeting resulted in the big reformation decision for SICET and provided a new and innovative path for SICET's growth and development.

对此大家进行了热烈的讨论,针对职责、任期时限、协同工作、理事人选题提 名和章程修改等逐一研究,既具有系统性又具有可操作性。大家一致认为,学会此 次改革意义重大,将积极推进实施。
