Report from the President (Feng-Qi)

- 1. Revision of the bylaw. Collaborating with Steve, Harrison, SICET Bylaw is revised and sent to the board to vote. The agreed revision will be presented to the SICET members at the 2006 AECT/SICET conference in Dallas.
- 2. Non-profit organization needs a long process. So it is on-going. Feng-Qi requested all board members to vote the revised version of Bylaw and appreciated board members' job this year.

Report from the Vice President (Youmei Liu)

Report from the SICET Student Online Discussion Forum Facilitator (Grace Lin)

The discussion forum was not set up because people who are not currently paid members but were on our old listserv --- their contact information cannot be retrieved.

Grace's suggestions:

- at this point, there is no need to set up a separate listserv for people who we cannot contact. However, if in the future, we like to have a separate listserv for non-members to have a feel for our society, that is a different issue.
- In addition, while investigating this issue, I realized that SICET does not have a "real" listserv - the kind that users can sign up, received automatic confirmation, can sign themselves off, have web-based archives, etc. When having a real listserv becomes important, then the board can discuss this issue.

Report from IJTTL Editor-in-Chief (Leping Liu)

- 1. The journal has caught more attention in the field (thanks to
- 2. Yuliang, he has sent the journal url, call for papers, and call for reviewers to eight very promising listserv). We have received some queries from our potential authors, but the submissions are not IN yet. We will continue spreading the words out wherever applicable.
- 3. We still need more quality manuscripts. Right now, the editorial team is making great efforts to help the authors revise their manuscripts to meet the standards of the journal.
- 4. Two new editorial reviewers have joined the review board, and a third one will be on board after he receives his degree.
- 5. The current issue (vol.2, issue 1) will be online soon. Manuscripts for the second issue are sending out for review.
- 6. Other work proposed in previous report is still in the planning/preparation phase.
- 7. Need volunteers to work on the design of an interactive communication system between the authors and readers.
